Instructional Team Fees/Payment Information: Monthly “Team Fees” are determined by the number of dances each participant is participating in and is recurring for Five Crown Fitness members and covers all rehearsals, coaching, choreography, music and consultation costs. Team fees and membership dues are payable on the 1st of each month and will be charged to the credit card in file with Glofox/Five Crown Fitness or Direct Debit. A five-day grace period will be allowed for declined dues. Parents will be notified when this occurs and a **\$15.00 late fee** will be applied to your account with any balance following the 5th of the month.

Costume & Competition Fees:

Costume/Competition fees will be billed to participants 30-90 days prior to an event. A \$250 per person non-refundable costume deposit is due on JUNE 23rd, payable to “Five Crown Elite Dance.” Payment should be handed directly to the front desk staff (Devin or Alexis) by check (recommended) or cash (in an envelope with your name on it). You will receive an email or written receipt of cash payment. If you do not receive an

email receipt assume that cash payment was NOT collected. Do not send cash payment in with your student and do not leave an envelope with anyone other than Devin or Alexis. We are not responsible for lost or stolen payments. Please note that there are deadlines we must uphold in an effort to keep costs at a minimum for both costume deposits as well as early registration pricing for competitions. Any person who is late in payment may be charged a late entry fee as well as may risk a costume not being ordered or arrive on time for a competition. Five Crown Fitness will not be held responsible for the consequences of late submissions including but not limited to a dancer not having a costume in their possession i.e. forfeiting the ability to dance in a competition. Competition fees include entry into the competitive numbers but in some cases do not include spectator fees or travel fees for events.

Please note: A delinquent account may result in your child being suspended from the team until payment in full is received. Monthly fees will continue to be charged with no credit given in the event of a suspension.

Cancelled Competitions: Occasionally a competition may be cancelled by the host organization. Should this happen, we may attempt to add another similar competition to the roster if time permits. Fees paid that are refunded by the cancelled host organization will be applied to the new competition or if no competition can be added, funds will be credited to your account.

All team members will pay for their own jewelry accessories (earrings, necklaces, hair items etc.) as well as their own dance shoes for practice and competitions including tights, make-up, etc. Jewelry items will be purchased through the Five Crown Elite program. Each team member is responsible for taking good care of and keeping track of their uniforms and accessories at all times. If any team member damages or loses a costume, they will be responsible to pay for the replacement or repair of the damaged costume and may forfeit dancing and competing if the costume cannot be replaced in time of the performance or competition (without refund of competition or instructional fees). Parents, please remind your dancer of the responsibility of caring for their items.

It is understood by Five Crown Fitness, L.L.C. and the Five Crown Elite parent (guardian) that services rendered by Five Crown Elite Dance are due and payable as outlined above. Should an account become delinquent, Five Crown Fitness, LLC reserves the right to take steps necessary, including legal action, to receive payment due for services rendered by Five Crown Fitness, LLC. Should legal action be necessary to recoup monies for a delinquent account, it is understood that an additional legal fee will be applied to the balance due, based on fees charged by the attorney representing Five Crown Fitness, LLC's interest. A 35% collection fee, based on the outstanding balance due will be added to the outstanding balance and submitted to a reputable collection agency should your account require these necessary steps to recoup monies on behalf of Five Crown Fitness, LLC

Practice times:

Practice times are outlined in the schedule that was sent to each individual dancer following team try-outs. Parents must notify frontdesk@fivecrownfitness.com of an absence (planned or otherwise) as soon as possible as well as intent to not participate in all dances they have been assigned. Dancers must learn all practice material prior to returning to practice via band videos or when necessary booking a private lesson with a coach for assistance (at the financial obligation of the dancer's family). Dancers with extensive absences will not be considered for ensembles (solos, duos, trios) and may be removed from dances in which they are not prepared to compete at the discretion of the coaching staff. In the case a dancer is not prepared to dance/perform for any reason, no refund will be given for costumes or rehearsals.

Dancers with injuries should expect to come to practice to watch and take notes.

Dancers with a fever or illness should not attend practice but should provide a doctor's note upon returning after 2 or more consecutive practices missed. Dancers that are missing a competition for the reason of illness or injury **must provide a doctor's note** and plan to attend the competition in the case that a dancer is able and not contagious.

Choreography

Teams will be instructed on and compete in various categories, age divisions and tiers. Each dancer has received a schedule that determined which style they qualify for, and should continue training throughout the year to maintain eligibility. Attending technique, ballet and acro classes frequently as well as working on flexibility and strength training at home are the key to enabling your dancer the opportunity to participate in every style available. Dancers may not qualify for certain styles if they have regressed for any reason in dance technique, are struggling to retain choreography or have less than ideal attendance or participation.

Five Crown Fitness, LLC owns the rights to all choreography instructed throughout the 2025-2026 season including but not limited to that given to solos/duos and ensembles and dancers may not compete or showcase these routines partially or fully, in any capacity, without written permission from the owners during or after the season has commenced. Additionally, team members, parents, friends and family members of dancers are **strictly prohibited from sharing video of choreography or music** on social media, via text, email, airdrop or any other means until May 4th, 2026. Choreography taught to Five Crown Elite Team Members is considered the intellectual property of Five Crown Fitness, LLC and may not be recreated or stolen without risk of legal action. Five Crown Fitness, LLC also owns the rights to all music edits and licensing as these are expenses incurred directly to the business.

A note on choreography: Teams and ensembles may learn specific “tricks” to be used in competitive routines and must not share these skills or any team choreography throughout the season in person or over social media channels, text, email, etc. Failure to abide by this request could result in termination from the team.

Acro/Contortion

Five Crown Elite members will engage in frequent acrobatic skills training from approved coaches who have been vetted in experience and teaching style as to be conducive to our team’s expectations as well as a standard of injury prevention to

ensure the safety and long term success of the dancers. We ask that any dancer wishing to train in any acrobatic or gymnastic style outside of Five Crown Fitness receive written permission from our staff to ensure injury prevention.

Commitment to 2025-2026 Competition Season

Because the Five Crown Elite Competitive Dance program is a season-long commitment, it is expected that all team members complete the 2025-2026 season in its entirety. If any team member drops from the team at any time throughout the season, the Five Crown Elite parent/adult student must pay the full month's instructional team fees regardless of the date of removal within that particular month to Five Crown Fitness, LLC. as well as an upcoming competition or costume fees that have been pre-paid for by Five Crown Fitness, LLC. **Note:** All unpaid fees will be subjected to late fees and collection/legal proceedings if necessary.

Removal/Dismissal from Five Crown Elite Team

Agreeing to become a participant in the Five Crown Elite Competitive Dance program includes your commitment to attend all rehearsals and competitions Dance Summit (optional) or those previously agreed upon in writing with the coaching staff. It also includes the commitment to respect the coaching staff and fellow dancers in our organization. If for any reason your dancer is unable to attend competitions, you agree to the financial responsibility to pay-in-full your dancer's portion of the team's entry fees and related coach fees as allocated above unless previously discussed in writing. Additionally, if a dancer or team parent is deemed not able to comply with our team values of respect and integrity a dancer may be removed from the program. In this case, no fees will be refunded with the exception of competition fees that have not yet occurred. If you have questions on potential conflicts please communicate your questions to frontdesk@fivecrownfitness.com.

Please note**:** We may be notified of a competition that is not presented to us at the time the competition schedule goes out. In those cases, as long as the coaches feel

there is reasonable time to prepare for the competition, we may add it to our competition line-up.

Please note: Attendance at practice the week prior to any competition is mandatory. If a dancer misses the final practice session prior to the upcoming competition, you may be removed from performing in that competition. Special circumstances to this rule may apply, only at the discretion of the coaching staff and directors. No competition fee credit will be given under any circumstance.

Competition Award Ceremonies

Five Crown Elite team members are not allowed to leave award ceremonies until they are completed unless very specific pre-arrangements have been made and cleared with the coaching staff. Failing to follow this rule may result in suspension from the team.

Display and Promotional Events

From time to time, we may be invited to attend local events on behalf of Five Crown Elite. This may include parades, events, fundraisers, talent shows, performance at local sporting events, as well as other various community events. We ask that dancers make every effort to attend and we will communicate this information as soon as it becomes available.

Hotel Accommodations

As a traveling competitive team, it will be necessary for us to have overnight stays when participating in long-distance competitions. A hotel block may be set up for long-distance competitions if you choose to take advantage of this and in many cases is a mandatory requirement, “stay-to-play” for our participation in some competitions. Dancers must stay at one of the block hotels we provide so that our teams do not risk disqualification.

Transportation and Housing of Team Members

Coaches, Directors and Employees of Five Crown Fitness, LLC are not allowed to transport any team member to and/or from practices, events or competitions. Also, it is

the sole responsibility of the parents to make arrangements for their child to be transported and cared for at events or competitions should the parent not be able to attend with their child. Five Crown Fitness and its employees cannot be responsible to make transportation arrangements for your child, or make housing arrangements for them should you not be able to attend a competition.

Responsibility of the Five Crown Elite Team Member

Practice Attire

Each team member must arrive to ballet and acro classes in black leotard, stirrup or footless tights, black shorts or ballet skirt. Hair must be pulled back tightly (preferably in a bun), with no loose hair. No gum or loose jewelry. Practice apparel will be specified and specific practice apparel must be purchased. Uniformity in the practice setting is necessary in order to properly execute dance and related skills, as well as allowing coaches to effectively evaluate and correct inconsistencies within the routine.

Promptness

The Elite team members must be on time. Tardiness is not acceptable. This is important for proper warm-up and stretching prior to practice. Continuous late arrivals or absences may result in suspension or termination from the program. Please do not drop your team member off for practice too early as we may not have proper child care in place. Ten minutes prior to class is ample drop-off time. Parents are welcome but not required to remain in the building during your child's practice times, with the exception of choreography days and specified rehearsals which may be denoted as "closed" rehearsals. **Please do not videotape any portion of rehearsal or master classes.** Coaches will videotape when they feel it necessary.

Behavior

Five Crown Elite team members and parents must conduct themselves in a professional manner both at practice as well as at competitions. They must be respectful of other team members and their belongings and show respect for their coaches and the facility at all times.

Attendance

It is a privilege to be a part of a competitive team and as a team, each member is an important part of making the team work. Practice and competition attendance is mandatory with the exception of pre-authorized family vacations and events.

Continuous absences may result in dismissal from the team. Absences from competitions are not acceptable and may result in dismissal from the team. The season competition schedule is posted early enough so that there should never be a conflict for the dancer except in the case of a true emergency or previous arrangement. If you are not attending practice for whatever reason please email or band chat.

Please note: If absences from team practice are excessive, the team member will be required to schedule private lessons with a coach. The standard private lesson fee will apply.

- Miscellaneous items which may be needed during the competition year
- Additional optional fan apparel offered throughout the year (t-shirts, hoodies, parent shirts, etc.)
- Expenses for Ensembles (solo, duo, trio, small group)

Team Apparel/Logo Usage

Five Crown Elite logos and merchandise are property of Five Crown Fitness, LLC and may not be duplicated on anything including apparel, team gifts, merchandise or otherwise. We have specific vendors that we work with and small businesses that we support. Should you desire for an apparel item not currently available, please contact frontdesk@fivecrownfitness.com with your request.

Communication between Parents and Five Crown Elite Coaching Staff

Quality communication between our coaches, parents and students is extremely important. We welcome you to call or email at any time should you have any questions or concerns. We are here to make this an enjoyable experience not only for your child, but for you as well. To that end, please do not share grievances or personal concerns via BAND app as this is a positive communication tool and resource forum and we intend to keep it as such. Please do not text coaches personal cell phone numbers except in the case of an emergency.

Behavior Expectations/Dismissal from Team (Students and Parents)

At Five Crown Fitness, LLC we pride ourselves in being student focused, that means that all decisions must be made with the best interest of the majority of our students in mind. If excessive negativity or gossiping becomes disruptive we reserve the right to take action in protecting the culture of our space and our teams by means such as, but not limited to, closing the lobby to parents, removing the band app, suspending students or parents from participation in our teams and in our business. We expect all participants to be on their best behavior at all times, both at practice as well as performances. We expect good sportsmanship of our students and parents. Should we experience a behavioral problem with any team member or their family, dismissal from the team may be necessary. Our coaching staff reserves the right to evaluate, and if necessary dismiss any student and/or parent that does not meet the behavioral expectations of the team or facility. We will not tolerate any negative discussion or negative behavior by any parent or student regarding another team member, other competing teams, or our own team. We expect our competitive team members and

their families to have positive attitudes regarding their fellow team members and the team in general. Good sportsmanship is ALWAYS expected.

Team Members/Parent Negativity

There may come a time when you do not agree with the policies set forth by the Five Crown Elite Competitive Dance Program and/or Five Crown Fitness, LLC. Please keep in mind that we put a lot of thought and time into every decision made and as we cannot please everyone, we strive to do what is best for the children and the program as a whole. Please bring all concerns and questions directly to the owners and refrain from openly displaying your dissatisfaction with the program, whether in our building, at competitions, online or related functions.

Coaching/Teaching

It is a conflict of interest for a team member to coach, help out, teach, assist or choreograph routines for another team outside of our organization, whether they are competitive or not, without written permission. Failure to follow this rule could result in suspension and/or termination from our program. Dancers should not be attempting to teach skills on social media or spot other dancers in acrobatics, stunts or partnering.

USASF Athlete Membership

All athletes are required to be a paid athlete member with the USASF (United States All Star Federation) which is the governing body for many of the competitions we attend. www.usasf.net Instructions on how to register will be provided at a later date as registration will occur on June 1st, 2025.

Big Sister/Little Sister Program

At the beginning of the competitive season, we will assign big and little sisters to each team member. During the year, prior to competitions, special events or “just because”, each team member is encouraged to send a little note or card of encouragement or good luck to their big and little sisters. You may also choose to purchase an inexpensive gift for your “sisters” but this is not required.

Social Media/Personal Behavioral Expectations

The expectations are that team members and their parents (family members) will conduct themselves in an appropriate manner at all times, which includes the use of social media and “group messaging/group texts”. How a team member or their family presents themselves in person or on any form of social media, is a reflection on the entire team, as well as the Five Crown Elite Dance Teams. Always make sure you and your dancer(s) are presenting themselves in a positive manner. We hold our reputation in high regards and will not tolerate negative social media posts and/or inappropriate behavior. Again, if you have an issue with the program, coaches or administration, please bring it personally to the owners. This is a zero tolerance policy. Suspension and/or termination from the program may ensue.

Five Crown Elite Fundraising/Booster Club

While we won't be directly organizing individual fundraisers for team members, we're happy to support families who are interested in starting a booster program to help with dancer-specific costs. Please notify us if you would like more information.

The coaching staff may organize multiple fundraisers throughout the season to help offset studio and team expenses. We appreciate your support of these initiatives.

No one is allowed to hold their own personal fundraiser under the auspices of Five Crown Elite or Five Crown Fitness, LLC. Anyone holding their own personal fundraiser for their dancer under the auspices of Five Crown Elite Dance Teams and/or Five Crown Fitness, will be dismissed from the program.

Waiver and Release of Liability

IN CONSIDERATION OF the risk of injury that exists while participating in a Five Crown Fitness, LLC/Five Crown Elite Instructional activity, including, but not limited to, group and/or individual instruction;

IN CONSIDERATION OF my desire to participate in classes, courses, rehearsals, meetings, events or other activities being held at and/or by representatives of Five Crown Fitness/Five Crown Elite and being given the right to participate in same;

I HEREBY, for myself, my heirs, executors, administrators, assigns, or personal representatives (hereinafter collectively, "Releasor," "I" or "me", which terms shall also include Releasor's parents or guardian if Releasor is under 18 years of age), knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity; and I HEREBY release and forever discharge FIVE CROWN FITNESS, LLC, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns (collectively "Releasees"), from any physical or psychological injury that I may suffer as a direct result of my participation classes, courses, rehearsals, meetings, events or other activities held at or by Five Crown Fitness, LLC/Five Crown Elite.

I AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK AND/OR AGREEING TO THE PARTICIPATION OF MY SON OR DAUGHTER AT HIS/HER OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH PARTICIPATING IN THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO: PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH. I UNDERSTAND THAT THESE INJURIES OR OUTCOMES MAY ARISE FROM MY OWN OR OTHERS' NEGLIGENCE, CONDITIONS RELATED TO TRAVEL TO AND FROM THE ACTIVITY, OR FROM CONDITIONS AT THE ACTIVITY LOCATION(S). NONETHELESS, I ASSUME ALL RELATED RISKS, BOTH KNOWN AND UNKNOWN TO ME, OF MY PARTICIPATION IN THIS ACTIVITY.

I FURTHER AGREE to indemnify, defend and hold harmless the Releasees against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs.

I FURTHER ACKNOWLEDGE that Releasees are not responsible for errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity on behalf of Releasees. In the event that I should require medical care or treatment, I authorize Five Crown Fitness, LLC to provide any emergency medical care deemed necessary, including but not limited to, first aid, CPR, the use of AEDs, emergency medical transport, and sharing of medical information with medical personnel. I further agree to assume all costs involved and agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

I FURTHER ACKNOWLEDGE that classes, courses, rehearsals, meetings, events or other activities may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to participate in the Activity unless I am medically able and properly trained, and I agree to abide by the decision of the Five Crown Fitness, LLC/Five Crown Elite official or agent, regarding my approval to participate in the Activity.

I HEREBY ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAIVER AND RELEASE" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE FIVE CROWN FITNESS, LLC/FIVE CROWN ELITE AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS AND ASSIGNS, FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST THE ABOVE MENTIONED FOR PERSONAL INJURY OR PROPERTY DAMAGE.

To the extent that statute or case law does not prohibit releases for ordinary negligence, this release is also for such negligence on the part of Five Crown Fitness, LLC/Five Crown Elite, its agents, and employees.

I agree that this Release shall be governed for all purposes by Michigan laws, without regard to any conflict of law principles. This Release supersedes any and all previous oral or written promises or other agreements.

In the event that any damage to equipment or facilities occurs as a result of my or my family's or my agent's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any such actions of neglect or recklessness.

THIS WAIVER AND RELEASE OF LIABILITY SHALL REMAIN IN EFFECT FOR THE DURATION OF MY PARTICIPATION IN THE ACTIVITY, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.

THIS AGREEMENT was entered into at arm's-length, without duress or coercion, and is to be interpreted as an agreement between two parties of equal bargaining strength.

Both Participant and Five Crown Fitness, LLC/Five Crown Elite agree that this agreement is clear and unambiguous as to its terms, and that no other evidence shall be used or admitted to alter or explain the terms of this agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.

In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.
